

## • Updates from summer work:

**Humanities report** (Dave) - Almost completed. Interesting positive correlations between student art appreciation attitudes and courses taken at HWC.

**Civic Engagement pilot** - took place in summer; collected data from over 50 students.

After AC execs reviewed the survey last week, Q5 and 7 underwent some editing, Q11 was significantly changed and simplified. Jeff distributed paper copies to the HWCAC members to review at home and bring to the next meeting with editing suggestions and/or corrections.

Members discussed whether to include a CE definition at the top of the survey.

## Reflection on FDW and plans for changing the showcase:

- FDW had a poor faculty attendance and there were very few faculty present at the AC department liaisons presentations.
- Alternative forms of presentations were discussed: podcasts, demonstrations, narrated presentations, posters, etc. It was decided that, individual liaisons can choose the form(s) of presentation, conducive to the departmental forms of communication. Stipulations: inform the HWCAC committee when the presentation is ready and produce an artifact reflective of presentation for archiving purposes.
- It is important to develop a regular tradition of informing administration about AC work, including pre-scheduled presentations.

## Goals for the year:

**Online learning** (Jen) - is planning to investigate the roots of a small but statistically significant surplus of positive attitudes about learning online in foreign language classes. Also, Jen is exploring assessment capabilities of Brightspace

**Co-curricular assessment -** As the position of Program-level liaison has been transformed into Co-curricular liaison, Jeff will spearhead data collection on what's been already/ currently done with respect of co-curricular assessment.

**Unit assessment -** Carrie informed that CD program pilots a district-wide CD assessment using the same assignment with the same rubric.

**General education (Civic Engagement)** - assessment tool will be finalized within the next 1-2 weeks and ready to be administered.

- Intro: Carrie called the meeting to order O3:O3pm
- **HLC prep:** Carrie was asking assessment-related questions that can be expected at the HLC session and the committee members discussed the answers.

## Q: What are we doing at the AC?

**A:** Assessing student learning. Historically, we focused on Gen Ed SLOs and, since the last HLC visit, expanded broader and deeper into assessment units smaller than Gen Ed (unit assessments within individual departments), online assessment and co-curricular assessment.

Q: What is "assessment unit"? How do you define it?

**A:** We define "assessment unit" as any unit of study beyond a single section of a course. In our largest assessment unit we assess General Education outcomes, in smaller units we assess outcomes of a series of courses or multiple sections of the same course.

## Q: How do you decide what to assess in these smaller units?

**A:** AC departmental liaison in consultation with department chair and faculty make that decision, thus, the units of assessment focus vary from department to department (it can be a series of courses or multiple sections of the same course).

# Q: Tell us about your program-level assessment.

**A:** At HWC we define a program as any unit of study that ends with a certificate or a degree. Program-level assessment is a new direction for us that will need a lot of planning and work and, as we currently envision, it will be developed by program coordinators with support from corresponding AC unit-level liaisons.

## Q: Tell us about your assessment tools and how you create them.

A: In the past, AC tried to use "pre-made" assessment tools and while the quality of questions was good, they were not adapted to the unique nature of our institution (two-year college, urban environment, huge diversity of student body, large number of non-traditional students, etc.). As a result, we developed a more "organic" approach of developing our own tools. The process starts with HWC subject matter experts deciding which Gen Ed SLO(s) to focus on and surveying what students are already doing. For example, for the latest Oral Communication assessment it was decided to assess student learning in courses that already have oral presentations as part of their curriculum and just use a common rubric. For many Gen Ed assessments questions are designed "from scratch," while for some, they can include a combination of self-designed and pre-existent questions (the latest NatSci assessment). All new assessment tools undergo close examination by the general committee before they are piloted to students. Further edits are introduced after the pilot.

## Q: How do you approach assessment in your online courses?

**A:** HWC considers "on-line" to be just a different mode of course delivery. HWC courses, regardless of whether they are delivered face-to-face, online or in a hybrid format, all have the same SLOs. Distance-learning students have been included in our Gen Ed assessment efforts for years. A recent development was creation of the HWC AC position of Online Learning Coordinator currently held by Jen Asimow and the first assessment that she created and administered for the online modality was attitudinal assessment of student learning. The OL assessment results allowed to issue a series of specific recommendations on pedagogical improvements in OL courses.

## Q: How do you close the assessment loop?

**A:** In addition to providing public access to all completed assessment reports on our website, the committee publishes a bi-yearly HWC AC Newsletter that summarizes assessment results and recommendations and allows faculty to share their assessment-based experiences. AC members present their projects and findings at the college-wide faculty development events. The committee designs and displays fliers about the assessment process, results and recommendations.

# Q: Tell us about your co-curricular assessment.

**A:** Historically, co-curricular area has been entirely under purview of our administration. Since the last HLC review, HWC AC welcomed several non-faculty members (two librarians, an advisor, a director of student services). The newest AC position is the Coordinator of Co-curricular assessment who is currently collecting information on existing co-curricular assessment practices and data.

- Intro: Carrie called the meeting to order at 3:04pm
- Review of minutes: 09-26-2018 meeting minutes were approved with suggested edits.
- **HLC visit debrief:** The AC members noted that the AC session and the visit in general went well. The AC session was well attended and multiple members answered questions.

Yev shared highlights of HLC debrief presented by Armen at the 10-03-18 HWC Leadership Team Meeting, including the fact that only 50% of faculty syllabi pulled by the HLC team matched corresponding Master syllabi. This fact prompted a discussion about how to ensure uniformity of course SLOs and how to update outdated syllabi and SLOs.

Jen shared feedback from the OL HLC session and that our OL learning challenges do not appear to be unique but similar to those in other institutions.

## AC liaisons updates:

Todd (Library Instruction): While piloting the "English 102: Boolean Operators" assessment tool
Todd noticed that students were confused by the assessment instructions and did not perform
well. Preliminary results show that clarifying assessment instructions significantly improved
assessment scores.

Also, Todd discovered that the second library instruction assessment tool on keywords did not match the SLOs of the library course.

 Paul (Art: Ceramics): Paul brought vessels from the Spring 2018 Art 196 Beginning Ceramics assessment to the meeting and demonstrated how the rubric was applied the thrown cylinders.

Paul is hoping the ceramics assessment pilot data will show instructors how students are meeting the expectations of throwing a cylinder on the potter's wheel. The assessment was done in just one section in the Spring, but will be in all 4 section this Fall. Another goal of assessing Art 196 is to see how well the wheel-throwing skills carry into Art 197, which is the next level ceramics course.



## • Chair updates:

- Carrie met with the chair of the HWC Curriculum Committee Gabriela Cambiasso in an attempt to align the work of our two committees. At this point, committees are pressed to find the avenues for collaboration but will continue to explore the options. Gabriela is planning to attend the next AC meeting.
- Angela Guernica, the Director of Student Activities, finished compiling the list of all student clubs and organizations at HWC and made it available for the AC to use in our CE assessment coming up next week.
- Adjournment and Approval of These Minutes: The meeting adjourned at 4:02 pm.

- Liaison updates

- Intro: Jeff called the meeting to order at 3:04 pm
- Review of minutes: 10-03-2018 meeting minutes were approved.
- Civic Engagement (CE) updates: The AC reviewed the latest draft of the Civic Engagement Assessment (Document Version), offered suggestions and edits. The discussion included the following topics:
  - Acknowledging that not all students are eligible to vote (e.g. international, underaged, undocumented)
  - o 4-point vs. 5-point Likert scale
  - Accounting for CE experiences of students that took classes outside of HWC or CCC
  - o Ensuring that the question language is not confusing for OL students

#### • Unit Assessment Liaison updates:

- O Aigerim (Biology): The focus of the project is Bio 121 course (introductory biology for Majors). A pilot 20-multiple choice question assessment tool has been created in Spring 2018 and piloted as post-assessment in five sections of the course, collecting data from over 90 students. The HWC Biology department Assessment Committee spent 8 hours during the Fall 2018 registration week discussing the results of the pilot and modifying the tool for the fall semester. In Fall 2018 the updated tool has been administered as a pre-assessment during the first week of classes with all 10 sections of the Bio 121 course participating. The same tool is planned to be administered at the end of the semester as a post-assessment.
- o Amy (English): The focus of the project is the English 102 course. Students who are still attending are assessed after the student-initiated withdrawal date has passed and are asked about the reasons behind their decision in persevering in the course, as well as perceived course challenges and helpful factors. The project presents a challenge in recruiting faculty for participation; alternatives were discussed (e.g. direct recruitment of students via email containing the tool link).
- o **Bral (Business):** The department continues using the tool developed over the last two semesters and administered as a pre-assessment taken early in a business student's tenure, followed by a separate later post-assessment effort after students take three other classes. In the past, the tool was administered directly to students via BlackBoard survey, this semester Bral had to rely on instructors for survey distribution which was more challenging. Another project involves an modifying the attitudinal survey (adapted from the OL survey developed by Jen Azimow) conducted was part of a larger school effort. A ~20% change in tool wording (for clarification purposes) appears to lead to improvements in student scores, but one has to be careful in comparing semester-to-semester results from non-identical surveys.
- O Matthew (ELL and WL): The main project this semester is continuation of the assessment focused on a sequence of ESL Speech courses (ESL Speech 98, 99, and 100) focused on assessing student end-of-the-semester skills in doing introductions in their speeches. Data from the last semester are being analyzed (using a common rubric and norming sessions). Speeches have been recorded and posted online so that raters could view and assess them.
- Camelia (Math): Administered a previous Math 118 assessment tool. To ensure participation, Camelia personally reached out to Math 118 HWC adjunct and online instructors. Over a 100 responses were obtained by week 3. It appears that slight edits in the tool lead to improvement of student scores. Working on closing the loop recommendations this semester. Planning to develop a BrightSpace shell for Math 118 course. (This shell will contain the syllabus and a variety of assessments for Math 118 that any instructor teaching the course could choose to utilize in the spring of 2019.)

#### **HWC Admin Meeting**

- Yev updated AC members on the 10/10/2018 AC execs meeting with administration (Vincent, Armen, Carrie and Yev were present):
- Administration plans to conduct a Student Satisfaction Assessment (Noel-Levitz tool). The tool is already purchased and will be shared with Carrie. AC will be consulted on the essay question part of the tool (up to 10 questions). Carrie's suggested admin to consider administering the tool in Spring 2019, so not to "clash" with the HWC AC CE assessment in Fall 2018. AC only has experience of assessing volunteers, the tool, however, requires to be administered randomly...
- Carrie updated admin on the current state of co-curricular assessment, and other AC updates (CE survey roll out, Humanities and Quantitative Reasoning reports are coming out, change in AC leadership in Spring 2019, Effective writing assessment tool will be developed in Spring 2019 for Fall 2019 administering).

#### **Shared Governance Meeting**

Jackie Werner made a presentation on the HWC Care Team (one of several HWC units that will be supporting Focus Area 3 of the HWC Strategic Plan: Climate: Culture, Data, and Students). Noteworthy, the Care Team will be using the results of the earlier-mentioned Student Satisfaction Assessment tool (Noel-Levitz).

Updates on the current work of the active HWC committees were provided: Carrie spoke about rolling out the CE assessment and collaborating with SGA in improving CE at HWC.

• **Civic Engagement Assessment:** the AC members further discussed and edited the tool questions and voted to approve it. Jeff will follow up with an email to the HWC AC members.

#### • Final Liaison Updates

Dave (Philosophy) reported the results of his direct assessment of students' critical reading skills and indirect assessment of student reading behaviors and beliefs about reading and learning. Critical reading scores were low but students with two or more previous philosophy classes were significantly more likely to correctly evaluate the argument quality but students with only one previous philosophy class were significantly less likely to correctly identify the conclusion. Among self-reported reading behaviors, "Before" (reading) behaviors scored the lowest and "After" behaviors - the highest. Among "During" behaviors, annotating and questioning scores were very low. One more finding was related to a pair of questions that asked students to evaluate the author's argument. One question asked whether the argument was "valid" and one question asked whether the argument's conclusion "could not be false when the premises were true," which is the definition of the term "valid" as it is used in a philosophical context. Student responses varied across the questions, with students doing much better when using the definition than when using the term, indicating that students interpretation of the term relies on its natural language use, rather than the technical use, even among students who had already completed philosophy classes, including logic wherein the technical meaning of the term is a key focus. Overall, the assessment data points to a number of specific opportunities in teaching students how to conduct critical and active reading, as well as important points of awareness for instructors.

- Review of minutes: 10-24-2018 meeting minutes were approved
- Assessment Times updates: AC members looked over the AT draft in MS Publisher format and discussed pictures. Fri Nov 11/9/18 was established as a firm deadline for changes and suggestions.
- Fernando Gen Ed QR update: Jeff is almost done with the report. For data analysis purposes, respondents were divided into several categories: "Stem category" those who took 4 or more STEM classes (it was decided to use this approach rather than the self-declared majors) and "Business/Economics category" those who took 3 or more Business and Economics classes and completed them with a C or more. The two groups were compared to the "all the rest" category of students. "STEM category" and "Business/Economics category" did not perform better than "all the rest" category. Similar results have been discussed in statistics education circles.

The AC members discussed the issues of readers' overconfidence, intentional misrepresentation, and visual competency, as they related to the QR assessment. Jen shared her own experience on completing the QR survey and how it changed the way she looks at graphs. She suggested that it would be great if students could look at their results and learn that way as well; Carrie informed the members that the assessment community is moving towards the real-time assessment which would make it easy to share results immediately.

The AC members discussed possible recommendations for this assessment, most prominently: encourage instructors to involve students in analysis of confusing and misleading graphs across the curriculum and to recommend STEM and Business students to take statistics.

Also, a close overlap between QR graph analysis skills and informational literacy has been pointed out the AC members were encouraged to reflect on how to support these key skills across the curriculum (in STEM and non-STEM disciplines) for the AC recommendations on the QR assessment report..

• Dave Gen Ed Humanities update: Dave reflected on the "stretched-out" timeline of the GE Humanities assessment (took place in Oct-Dec 2017; 1st round of ratings completed in April-May 2017; 2nd round, and 3rd for some entries, completed by Fall 2017; 1st batch of data from Phil was on language analysis in Fall 2017; Erica, Dave and Phil completed main data analysis only in Spring 2018). Since then Dave already wrote History, Methodology and write up of 10 survey questions for the report. He has sufficient information to do a write up on four more questions but is unsure about the data on the remaining two questions.

Dave reported the issue of validity of some data due to sample number confusion in regards to some questions ("N"s do not add up) and the high number of English 102 completers in the sample (282/605), suggesting the sample is likely non-representative of general education students. Fernando commented that it usually happens when student IDs are incorrect, or when students do not have OpenBook record (e.g. as in case of transfer) but, typically, the number of affected responses is much lower. AC member discussed observed patterns of student performance and correlations with courses taken, and the lack of statistical significance.

It's been decided to ask Phil to look at the confusing part of the data and, if necessary, to return to raw data (Carrie).

AC members will review Dave's findings and provide feedback.

- **Gen Ed Civic Engagement updates:** Carrie reported that after over a week only 130 responses were obtained so far, which is low. Carrie will be sending a reminder email to all faculty this week. We will follow up with another request to the "friends of AC" soon.

- OL assessment updates (Jen):

The original project - assessment of online English 102 had encountered multiple obstacles pertaining to data collection (data not submitted; wrong rubric used) which cut down the number of respondents to only two sections of the course making it difficult to interpret the results.

The 2nd project focused on OL ELL courses (French & Spanish) where students expressed a higher level of OL learning satisfaction (data was statistically significant). Turns out that these classes are based entirely on an excellent interactive externally designed courses (Vista Supersite book companion). Jen is planning to design a survey that will allow to pinpoint the specific sources of student satisfaction in these courses. It will also be interesting to examine whether students prefer a high-quality pre-designed OL courses to the home-grown ones.

A possibility of administering assessment surveys directly to OL students have been discussed (again!). Discuss with Meghan / Adolfo.

• **Gen Ed Civic Engagement updates (Erica):** It's time to reach out to the department colleagues and friends of the AC.

# • 11-13-18 Shared Governance meeting updates (Yev)

SGA has appointed SGA secretary Ivan Loeza to also function as faculty liaison (potential point of contact if we decide to distribute Gen Ed assessment surveys directly to students).

President Lopez emphasized the importance of ongoing "Educational Equity" discussion that should permeate all the components of the HWC strategic plan; he is interested in the emphasis on a sense of belonging in these politically difficult times.

Kent Lusk provided budget updates.

Armen informed that we are still waiting on the HLC feedback, most likely, until mid-January.

## Carrie: District Assessment Update

Brandon Nichols (BN) from the District Office (Accreditation, Assessment, Educational Development Academic & Student Affairs) has solicited Carrie's opinion and advice on the state of assessment district-wide, specifically, on how to ensure stability and continuity of assessment across the district.

BN: Should there be District-wide GenEd outcomes?

HWCAC members discussed it and considered it a possibility - since Gen Ed outcomes are similar across different institutions. Formulating them across colleges and disciplines, however, is a difficult task, especially given that different CCC colleges have different program offerings. Perhaps it's more practical for each college to have their own wording and, then, differences (if any) could be discussed.

HWCAC maintains the HWC Gen Ed SLOs on its website.

BN: Should there be a District-wide calendar of Gen Ed assessment?

HWCAC members discussed it and recommended against it. While HWCAC strictly adheres to its assessment calendar at the semester scale, on a day-to day and week-to-week basis it enjoys the flexibility of a local calendar, which can be easily adjusted to various college events, unit-level assessments, etc. Additionally, having a local calendar further ensures that assessment process is driven by faculty and is not enforced top down from the DO. Assessment centralization is likely to lead to a situation where a very few people will do a lot of work for the whole group, which contradicts the home-grown faculty-driven nature of assessment.

It appears that AC from other CCC schools need guidance but not directives. Standards/SLOs can be the same across the district but ways to assess them can be different and specific to each college (and student population). HWCAC emphasizes the importance of starting small, focusing on assessing one thing, and building together from there... HWAC is willing to help and share the structure, charge, tools etc.

## Jen: Online Assessment Update

Jen has created a brief survey for the Online Foreign Language students to explore the statistically significant higher level of student satisfaction in these Vista Supersite-based online courses.

Jen seeked HWCAC opinion on whether to follow the previously established protocol of administering assessment surveys via faculty or to email it to students directly or via faculty to streamline the process (in latter case, faculty would be notified).

HWCAC members discussed pros and cons of both approaches. The importance of the transparency of this modified was emphasized. It's been suggested that upon notification of instructors, they can be offered an option to "reinforce" survey completion via additional announcements to students and offering extra-credit. Domenico motioned to pilot administering the survey to OL ELL students directly, which was seconded by Amy and unanimously supported by all the AC members present.

## • Jeff & Carrie: TLC Day (Spring 2019)

The general idea is to have CAST and other committees to come together on topics about teaching. TLC planning meeting will take place tomorrow (Thu 11-29-18).

Carrie strongly recommended that the date has to be set (and distributed) by the end of this semester. Rather than driving the whole event (as it was in the past), AC will be responsible for a specific part of the content (e.g., CE theme, which will allow to discuss the results of the CE survey college-wide).

AC members discuss format possibilities: simultaneous, concurrent sessions or a mix.

It's been suggested to include Brightspace training and have faculty to pre-sign-up for sessions (in case of concurrent sessions) to ensure that they will be attended.
